WHEREAS, ROGER WAS A WELL-KNOWN AND WELL-RESPECTED LIFELONG RESIDENT OF KEESEVILLE; AND

WHEREAS, ROGER WAS PREDECEASED BY HIS WIFE EULEE POLAND ON JANUARY 30, 1992; AND

WHEREAS, ROGER IS SURVIVED BY HIS FOUR CHILDREN, LOLA AND ROMAN LOPEZ, CECELIA "TEAL" AND LONNIE LAUTENSCHUETZ, RANDY POLAND AND KAREN POLAND; FIVE GRANDDAUGHTERS, ANITA COLE, LAURA KENNEDY, TESSA PROULX, KARI AND KENDRA LAUTENSCHUETZ; SIX GREAT- GRANDCHILDREN, JALYN ISAIAH, DELANY, LENA, JAXON AND OTIS; AND

WHEREAS, ROGER IS ALSO SURVIVED BY TWO SISTERS AND ONE BROTHER-IN-LAW, JANE AND NYLES McNIERNEY AND MARY HATHAWAY; HIS GODDAUGHTER VESTA AND SPECIAL FRIENDS VICKY AND GARY TROMBLEY, AS WELL AS MANY NIECES AND NEPHEWS; AND

WHEREAS, ROGER E. POLAND WAS A LOVING SON, HUSBAND, FATHER, GRANDFATHER, GREAT-GRANDFATHER, BROTHER, UNCLE AND FRIEND AND WILL BE SORELY MISSED BUT NEVER FORGOTTEN; AND

UPON A MOTION BY COUNCILMAN KLAGES AND SECONDED BY COUNCILMAN BARBER AND UNANIMOUSLY CARRIED IT WAS

#96 RESOLVED: THAT THE READING OF THE MINUTES OF THE MEETING HELD ON JULY 10, 2018 BE DISPENSED WITH.

SUPERVISOR MORROW OFFERED THE COURTESY OF THE FLOOR TO THE GUESTS.

PATRICIA DELAMATAR SPOKE ON BEHALF OF THE KEESEVILLE FREE LIBRARY. SHE REQUESTED THAT THE TOWN BOARD PLEASE CONSIDER A BUDGET INCREASE OF \$1000.00 FOR THE YEAR 2019.

SUPERVISOR MORROW STATED THAT THE LIBRARY IS AN ASSET TO THE COMMUNITY AND THEY DO AN EXCELLENT JOB.

CINDY DOYLE GAVE AN UPDATE ON THE UPSTONE FACILITY. SHE INFORMED THE TOWN BOARD THAT DEC DID DO AN INSPECTION AND A DELIVERY WAS WITNESSED. CINDY AND HER HUSBAND ARE IN CONTACT WITH RANDY LAROSE FROM DEC; AIR QUALITY WILL CONTINUE TO BE MONITORED. SOME IMPROVEMENTS HAVE BEEN MADE; BUT STILL ISSUES. THE DOYLE'S STATE THAT THEY WILL REMAIN VIGIL AND WILL DO NECESSARY PAPERWORK AND SEND PICTURES AND WILL CONTINUE THE FIGHT. THE DOYLE'S THANKED THE TOWN BOARD FOR THEIR SUPPORT.

SUPERVISOR MORROW STATED THAT HE SPOKE WITH RANDY LAROSE ALSO. UPSTONE HAS ADDED NEW SEALS, NEW MONITORING SYSTEMS AND A CAMERA SYSTEM HAS BEEN INSTALLED. THE TOWN WILL CONTINUE TO SUPPORT THE DOYLE'S.

SUPERVISOR MORROW INFORMED THE TOWN BOARD THAST THERE IS A PROBLEM AT THE COMPACT STATION WITH PEOPLE USING THE PORT-A-POTTY AFTER HOURS AND LEAVING IT A MESS. PEOPLE ARE ALSO BRINGING IN ITEMS AND JUST LEAVING THEM THERE. HE ASKED THE TOWN BOARD TO CONSIDER INSTALLING A CAMERA SYSTEM. TWO CAMERAS WITH INSTALLATION AND COMPUTER SET UP WOULD COST \$1700.00. THE SYSTEM WOULD HAVE HARD DRIVE AND BATTERY BACKUP.

UPON A MOTION BY COUNCILMAN KLAGES AND SECCONDED BY COUNCILMAN BARBER AND UNANIMOUSLY CARRIED IT WAS

#97 RESOLVED: THAT SUPERVISOR MORROW BE APPROVED TO MOVE FORWARD WITH HAVING A CAMERA SYSTEM INSTALLED AT THE COMPACT STATION, THE COST NOT TO EXCEED \$1700.00.

SUPERVISOR MORROW INFORMED THE TOWN BOARD THAT THE 30MPH SPEED LIMIT ON THE SOPER ROAD HAS BEEN EXTENDED FROM VILLAGE TO PAST JAYCEE PARK. A REQUEST HAS NOW BEEN MADE TO REDUCE THE SPEED FROM 55MPH TO 45MPH FROM PAST JAYCEE PARK TO THE END OF THE SOPER ROAD. SUPERVISOR MORROW SUGGEST THE 45MPH BE CONTINUED TO ROUTE 373.

UPON A MOTION BY COUNCILMAN GLOAD AND SECONDED BY COUNCILMAN BLAISE AND UNANIMOUSLY CARRIED IT WAS

#98 RESOLVED: THAT THE SPEED LIMIT BE REDUCED FROM 55MPH TO 45MPH FROM PAST JAYCEE PARK TO ROUTE 373

SUPERVISOR MORROW INFORMED THE TOWN BOARD THAT HE MET WITH SID MAICUS, GORDON HOWARD AND PAUL KNOTT REGARDING THE FISH BARRIER. THE COST WAS ESTIMATED AT \$15,000.00 AND NOW IS UP TO \$18,000.00.THE AUGAR LAKE PLANT GROWTH DISTRICT HAS \$16,500.00. STEVE LAMERE NEEDS TO BE PAID AND THAT WILL LEAVE BALANCE OF \$13,300.00.

SUPERVISOR MORROW WILL CHECK WITH DEC TO SEE IF CARP CAN BE STOCKED WITH OLD FISH BARRIER. HE RECOMMENDED THAT THE REPRESENTATIVES OF THE FISH BARRIER COMMITTEE LOOK FOR ALTERNATIVES.

SUPERVISOR MORROW GAVE AN UPDATE ON THE APA FINDINGS REGARDING THE NEED FOR **PROPOSAL #2 FROM ADIRONDACK ECOLOGIST, LLC.** THE OBJECTIVE OF PROPOSAL #2 IS A MONITORING PLAN TO OBTAIN MORE DETAILED SCIENTIFIC INFORMATION WHICH MAY HELP DIRECT FUTURE GRASS CARP STOCKINGS.

PROPOSAL #2 COVERS THE FOUR FOLLOWING TASKS, WHICH ARE TO BE PERFORMED IN 2018 AS DIRECTED BY THE APA:

- 1. CONTINUE MEMBERSHIP IN THE CITIZENS STATEWIDE LAKE ASSESSMENT PROGRAM (CSLAP) AND REVIEW THIS INFORMATION AS IT BECOMES AVAILABLE EACH WINTER/SPRING.
- 2. PERFORM A DISSOLVED OXYGEN/TEMPERATURE PROFILE AT THE LAKE'S BASIN ONCE IN AUGUST. THE PROFILE WILL BE CONDUCTED IN 1 METER INTERVALS AND WILL BEGIN AT THE SURFACE (DEPTH 0) AND WILL CONTINUE TO WITHIN ½ METER OF THE DEEPEST PORTION OF THE LAKE BASIN. THE GPS COORDINATE WILL BE TAKEN FOR THIS SURVEY LOCATION. A TEMPERATURE/DISSOLVED OXYGEN VERSES DEPTH PROFILE WILL BE TABULATED AND THE MAXIMUM DEPTH, THE DEPTH OF THE THERMOCLINE (IF PRESENT), AND ANY NOTES REGARDING CURRENT AND RECENT (I.E. WITHIN THE PAST FEW DAYS) HISTORIC WEATHER WILL BE PRESENTED;
- 3. IF THE DISSOLVED OXYGEN VALUE IS LESS THAN 4MG/I OR IF THE DISSOLVED OXYGEN PERCENT SATURATION IS LESS THAN 30% THAN A HYPOLIMNECTIC WATER SAMPLE WILL BE OBTAINED FROM I METER ABOVE THE SEDIMENT AND THIS SAMPLE WILL BE ANALYZED FOR TOTAL PHOSPHORUS;
- 4. PERFORM (1) RAKE TOSS AT EACH OF SITES #1-6 ON THE LAKE AND APPLY THE US ARMY CORP ABUNDANCE SCALE ON TH SAMPLES OBTAINED. A TABLE WILL BE PREPARED PRESENTING THIS DATA. DATA WILL INCLUDE GPS COORDINATE OF EACH SITE AND A LIST OF ALL SPECIES PRESENT AND THE OVERALL ABUNDANCE (US ARMY CORPS OF ENGINEERS SALE OF ABUNDANCE) OF EACH SPECIES WILL BE NOTED. ALL RAKE TOSSES SHALL BE TAKEN FROM WITHIN 50 FEET OF THE GPS COORDINATE REPORTED IN THE 2017 REPORT.

THE PROPOSAL TOTAL FOR THE 2018 ENVIRONMENTAL SERVICES PROPOSAL #2 PACKAGE IS \$1,250.00.

UPON A MOTION BY COUNCILMAN BLAISE AND SECONDED BY COUNCILMAN KLAGES AND UNANIMOUSLY CARRIED IT WAS

#99 RESOLVED: THAT PROPOSAL #2 FROM ADIRONDACK ECOLOGISTS, LLC BE APPROVED CONTINGENT UPON THE ALLOWING OF THE STOCKING OF CARP FOR THE YEAR 2019.

SUPERVISOR MORROW INFORMED THE TOWN BOARD THAT HE RECEIVED A LETTER FROM NYSDEC REGARDING THE PURCHASE OFA PARCEL OF LAND OWNED BY ARTHUR JUBIN IN THE TOWN OF CHESTERFIELD. THE PROPOSED USE FOR THE ACQUISTION WOULD BE A BOAT LAUNCH ON AUGUR LAKE. THE TOWN OF CHESTERFIELD HAS A 90 DAY TIME PERIOD TO RESPOND TO THE PROPOSED ACQUISITION IN SUPPORT OF OR OPPOSITION TO THE USE.

RESOLUTION # 260 BY THE ESSEX COUNTY BOARD OF SUPERVISORS OPPOSING THE PURCHASE BY NEW YORK STATE DEPARTMENT OF ENVIRONMENTAL CONSERVATION OF A PUBLIC BOAT LAUCH SITE ON AUGUR LAKE IN THE TOWN OF CHESTERFIELD WAS ADOPTED AND UNANIMOUSLY SECONDED ON AUGUST 6, 2018.

UPON A MOTION BY SUPERVISOR MORROW AND SECONDED BY COUNCILMAN KLAGES, COUNCILMAN BARBER AND COUNCILMAN BLAISE IT WAS

#100 RESOLVED: THAT THE TOWN OF CHESTERFIELD TOWN BOARD AND ITS RESIDENTS OPPOSE THE PURCHASE BY THE NEW YORK STATE DEPARTMENT OF ENVIRONMENTAL CONSERVATION OF LAND FOR A PUBLIC BOAT LAUNCH SITE ON AUGUR LAKE IN THE TOWN OF CHESTERFIELD; AND

WHEREAS, IT HAS COME TO THE ATTENTION OF THIS TOWN BOARD THAT THE NYSDEC IS CONSIDERING THE PURHASE OF LAND FROM A PRIVATE INDIVIDUAL LOCATED ON AUGUR LAKE FOR THE PURPOSE OF A CREATING A PUBLIC BOAT LAUNCH: AND

WHEREAS, THIS BOARD IS AWARE THAT THE NYSDEC HAS BEEN DILATORY IN ITS UPKEEP, MAINTENANCE AND REPAIR OF THE EXISTING BOAT LAUNCHES WITHIN ESSEX COUNTY AND THEREFORE, THE MONIES BEING USED FOR THE PURCHASE OF THE LAND AND ESTABLISHING A BOAT LAUNCH ON AUGAR LAKE WOULD BE BETTER SERVED TO BE USED TO REPAIR AND MAINTAIN EXISTING FACILITIES.

BE IT RESOLVED, THAT THE TOWN OF CHESTERFIELD TOWN BOARD DOES HEREBY OPPOSE THE PURCHASE OF LAND BY THE NYSDEC FOR THE ESTABLISHMENT OF A PUBLIC BOAT LAUNCH ON AUGUR LAKE AS IT IS NOT NEEDED, IS AN UNNECESSARY EXPENSE AND THE NYSDEC MONIES WOULD BE BETTER SPENT REPAIRING AND MAINTAINING EXISTING FACILITIES; AND

BE IT FURTHER RESOLVED THAT A COPY OF THIS RESOLUTION BE FORWARDED TO: NYSDEC COMMISSIONER ROBERT STEGMAN; SENATOR ELIZABETH LITTLE AND ASSEMBLYMAN DAN STEC.
