SUPERVISOR MORROW OPENED THE PUBLIC HEARING AT 6:45P.M.

TOWN CLERK JARVIS READ THE LEGAL NOTICE. PROOF OF NOTICE WAS PRESENTED TO THE TOWN BOARD. A COPY OF THE LEGAL NOTICE CAN BE FOUND ON FILE IN THE OFFICE OF THE TOWN CLERK.

**GUEST PRESENT:** RON RODGERS, DON BOGUCKI AND SCOTT RACETTE.

SUPERVISOR MORROW SUMMARIZED THE 2019 PRELIMINARY BUDGET. SUMMARY AND ANALYSIS SHEETS WERE PRESENTED TO THE TOWN BOARD MEMBERS. THERE WERE NO CHANGES MADE SINCE REVIEWED AT BUDGET WORKSHOP. THE BUDGET IS \$47,000 BELOW TAX CAP. THE GENERAL BUDGET IS DOWN 2.8%, THE HIGHWAY BUDGET IS DOWN 0.98%. THE SPECIAL DISTRICTS DO NOT FIGURE INTO THE TAX CAP. THE FIRE DISTRICT INCREASED 7% DUE TO CVPH INCREASING AMBULANCE FEES. THERE WILL BE AN OVERALL BUDGET INCREASE OF 0.63%.

SUPERVISOR MORROW INFORMED THE TOWN BOARD THAT THERE IS \$33,213,546.00 WORTH OF TAX EXEMPT PROPERTY IN THE TOWN OF CHESTERFIELD.

SUPERVISOR MORROW OFFERED THE COURTESY OF THE FLOOR TO ANYONE WISHING TO MAKE COMMENT ON THE 2019 BUDGET.

WITH NO ONE WISHING TO SPEAK IN FAVOR OF OR AGAINST ANY ITEMS CONTAINED IN THE 2019 PRELIMINARY BUDGET SUPERVISOR MORROW DULY CLOSED THE PUBLIC HEARING AT 7:00P.M.

SUPERVISOR MORROW CALLED THE REGULAR TOWN BOARD MEETING TO ORDER AT 7:00P.M.

SUPERVISOR MORROW SPOKE ON INFORMATION FROM THE 2019 PRELIMINARY BUDGET THAT WAS REVIEWED IN PUBLIC HEARING.

THE BUDGET IS BELOW THE TAX CAP, GENERAL BUDGET DOWN 2.8%, HIGHWAY BUDGET DOWN 0.98%, FIRE DISTRICT INCREASED 7% AND HEALTH INSURANCE INCREASED 1.5%. THE OVERALL BUDGET INCREASE IS 0.63%.

UPON A MOTION BY COUNCILMAN KLAGES AND SECONDED BY COUNCILMAN GLOAD WITH COUNCILMAN BLAISE AND COUCILMAN BARBER AND SUPERVISOR MORROW ALL VOTING AYE IT WAS

**#144 RESOLVED:** THAT THE 2019 PRELIMINARY BUDGET BE ADOPTED. A COPY CAN BE FOUND ON FILE IN THE OFFICE OF THE TOWN CLERK.

SUPERVISOR MORROW OFFERED THE COURTESY OF THE FLOOR TO THE GUESTS. NO ONE WISHED TO ADDRESS THE TOWN BOARD AT THIS TIME.

SUPERVISOR MORROW GAVE AN UPDATE ON THE AUGUR LAKE FISH BARRIER PROJECT. THE PROJECT IS COMPLETED FOR THE SEASON. APA HAS LOOKED AT THE PROJECT AND THEY ARE SATISFIED. APA AND DEC APPROVE THE DAM FOR CARP STOCKING. SUPERVISOR MORROW THANKED THE HIGHWAY DEPARTMENT AND THE AUGUR LAKE RESIDENTS THAT WORKED ON THE DAM AND FISH BARRIER HELPING TO MAKE IT A SUCCESSFUL PROJECT.

SUPERVISOR MORROW GAVE AN UPDATE ON THE BUTTERNUT POND INVASIVE SPECIES PROJECT. DIVERS ARE WORKING ON WRAPPING INTAKE LINE TO PREVENT DEBRIS FROM ENTERING. THE MATS WHICH ARE 12'WIDE X 100' LONG ARE BEING PUT DOWN TO HELP KILL THE INVASIVE SPECIES; REBAR AND CRUSHED STONE IN BAGS ARE BEING PLACED ON MATS TO HOLD THEM IN PLACE. THE MATS WILL COVER AP-PROXIMATELY ONE (1) ACRE. THE LIFE OF THE MATS IS TEN (10) YEARS AND THEY CAN BE MOVED TO DIFFERENT AREAS OF THE POND.

SUPERVSIOR MORROW INFORMED THE TOWN BOARD THAT A GRANT IS AVAILABLE THROUGH THE LAKE CHAMPLAIN BASIN PROGRAM IN THE AMOUNT OF \$15,000.00. SUPERVISOR MORROW WOULD LIKE APPROVAL TO APPLY FOR THIS GRANT ON BEHALF OF THE TOWN SO WORK ON THE INVASIVE SPECIES IN BUTTERNUT POND CAN BE CONTINUED. THIS IS A NO MATCH GRANT. COMMUNITY RESOURCES IS ASSISTING WITH THE RANT APPLICATION. LETTERS OF SUPPORT WILL BE REQUESTED FROM SENATOR LITLE, ASSEMBLEYMAN STEC, DEC, APA AND THE DOH.

UPON A MOTION BY COUNCILMAN GLOAD AND SECONDED BY COUNCILMAN BARBER AND UNANIMOUSLY CARRIED IT WAS

THE PROBLEMS WITH THE WATER SYSTEM WERE INHERITED FROM THE FORMER VILLAGE OF KEESEVILLE AND EPA MANDATES THAT THE TOWN CONTINUE WITH IMPROVEMENTS TO RESOLVE THE ISSUES. SOME SITES WERE UNSUCESSFUL SOURCES FOR WELLS; CURRENTLY THERE IS ONE WELL ON OUR PROPERTY THAT IS PUMPING APPROXIMATELY 150 GPM. WE WILL NEED TO USE BUTTERNUT POND TO SUPPLEMENT WATER SUPPLY TO MEET THE TOWN'S NEEDS. THE CURRENT FILTRATION SYSTEM WILL NEED TO BE ENHANCED. HYDROSOURCE ASSOCIATES SUBMITTED A WRITTEN REPORT TO SUPERVISOR MORROW AND A COPY WAS GIVEN TO THE TOWN BOARD MEMBERS.

COUNCILMAN GLOAD DISCUSSED THAT THE TOWN OF WILLSBORO HAS ESTABLISHED A FUND RAISING PROGRAM FOR THEIR HOMETOWN HERO PROGRAM AND HE SUGGESTED THAT A SIMILAR FUND SHOULD BE ESTABLISHED FOR FUTURE REPAIRS IN OUR TOWN.

THE PURPOSE OF THE MEMORANDUM OF UNDERSTANDING (MOU) IS TO DESCRIBE AN AGREEMENT AMONG THE MUNICIPAL GOVERNMENTS IN THE ADIRONDACK PARK IN REGARDS TO THE LEVELS OF CHLORIDES IN ADIRONDACK GROUND AND SURFACE WATERS BY REDUCING THE APPLICATION OF ROAD SALT MAINTENANCE AND DE-ICING PRACTICES. THE MOU IS NOT A BINDING COMMITMENT, BUT RATHER A PLEDGE OF INTENT ON THE MUNICIPALITIES SIGNING THE DOCUMENT TO WORK IN GOOD FAITH TO CREATE AN EFFECTIVE PROGRAM TO REDUCE THE LEVELS OF ROAD SALT APPLICATION.

SUPT. OF HWYS PRAY INFORMED THE TOWN BOARD THAT THE TOWN OF CHESTERFIELD USES APPROXIMATELY 600 TO 800 TON OF ROAD SALT PER YEAR, ONE OF THE LOWEST IN THE COUNTY.
